If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times. With the issuance of this permit, the total combined duty of water allowed under Permits 34750, 38766, 38767, 40303, and 40304 is reduced to 47.0 million gallons per annum.
